Responsibilities:

- 1. Assist in the collection of biological data using seines, mask and snorkel, electro fishing, and beach and boat seine utilizing standard data collection protocol.
- 2. Assist in the maintenance of all biological and hydrological sampling equipment.
- 3. Construction, placement, maintenance, and physical monitoring of select out migrant rotary screw traps.
- 4. Collect and record fish health conditions, fish abundance and distribution information and relay recorded information to designated staff.
- 5. Collect scale samples and recover coded wire tags for age composition and stock origin analysis.
