The Karuk Tribe Housing Authority (KTHA) requests qualifications for the following Scope of Work required for a **Youth Wellness Program HEAD COACH** for the Yreka community. Interested individuals would need to be available to work the week of November 19-21, 2018 (depending upon position(s)). You may submit for the entire week which includes basketball, soccer and volleyball or you can apply for an individual sport(s).

A stipend of \$60 per day (2 hours) will be paid upon submission of all applicable paperwork required for payment (including background authorization and W9 forms).

### Task One

Head Coach will be responsible for planning and organizing sports program(s) (basketball, soccer, and volleyball) for children grades K-8<sup>th</sup>.

### Task Two

Teach the basics/fundamentals of the sport(s) with skill building and game time, arrive early to assign tasks to volunteers and high school student workers, oversee logistics and equipment. Must be enthusiastic and positive with children and helpers.

### Task Three

Oversee a two hour program from 10am to 12pm for students K-8<sup>th</sup> grade. Monday-Basketball, Tuesday-Soccer and Wednesday-Volleyball.

### Task Four

Maintain groups, individual discipline, and observe all Wellness Center Rules and Regulations while implementing the sports program and providing gym supervision.
