Summary:

Responsible for supervising and training the team for the drop and count of the VLT machines, table games drop and poker count.

Responsibilities:

- 1. Maintain schedule and rotation for team, so that it is within compliance with MICs.
- 2. Responsible for operating a variety of Soft Count equipment, and contacting vendors for maintenance schedules.
- 3. Ensure the integrity of all Soft Count transactions,
- 4. Held accountable, to a high degree, for accuracy and thoroughness of departmental paperwork.
- 5. Enforce Rain Rock Casino's Policies and Procedures, Drop Team/Soft Count Procedures at all times.
- 6. Provide information and explain Players Club benefits, property amenities & marketing programs to our guests.
- 7. Communicate effectively both orally and in writing.
- 8. Shall be polite and maintain a priority system in accepting other position related job duties as assigned.

LEVEL OF AUTHORITY & RESTRICTIONS

- 1. Supervise and train team in the VLT drop.
- 2. Supervise and train the proper procedures for counting, verifying and strapping all currency and gaming chips.

WORKING CONDITIONS & ENVIRONMENT

- 1. The noise level in the work environment is usually loud.
- 2. Must be available to work in a smoke-filled environment.
- 3. Must be able to multitask.
- 4. Must be able to stand up to 10 hours at a time.
- 5. Must be able to handle mental and physical stress.

- 6. Must possess excellent cash handling experience as well as basic math skills.
- 7. Must have computer experience.
- 8. Good customer service skills
- 9. Good public relations skills; professional appearance and demeanor.
- 10. Must possess reasonable ability to communicate in English.
- 11. Highly self-motivated and directed.
- 12. Good verbal and written communications skills.
- 13. Keen attention to detail.
- 14. Proven analytical, evaluative, and problem-solving abilities.
- 15. Ability to effectively prioritize and execute tasks in a high-pressure environment.
- 16. Extensive experience working in a team-oriented, collaborative environment.
- 17. Must possess and maintain a valid state driver's license and be insurable by the RRC's insurance carrier.
- 18. Willing to travel and participate in training as recommended or required.
- 19. Must have a Tribal Gaming License (or the ability to obtain and maintain a license) as a requirement for this position.
- 20. Must have employment eligibility in the U.S.
- 21. Must adhere to confidentiality policy.
- 22. Must successfully pass a drug screening test and criminal background check.
- 23. Indian preference will be observed in the hiring process.
