The Karuk Tribe requests proposals for the following Scope of Work required for the production of **four (4) 1.5 hour lesson plans and supplementary materials** for middle and high-school grade levels focusing on tribal physical health in connection with the local traditional food system to be completed from August 1, 2018 until September 15, 2018.

Contractor will work closely with the Pikyav Field Institute Program Manager (Program Manager) and K-12 Environmental Education Division Coordinator (K-12 Coordinator) to provide classroom materials and hands-on activities for K-12 students that convey an understanding of local traditional food system and the connection between physical health and Native foods, using the Karuk language in lesson materials whenever appropriate and possible.

The Contractor's lesson materials and supplemental field activity guides will follow the style and format of similar materials integrated into the Karuk Tribe's **Nanu'ávaha K-12 Native Food System Curriculum** (Nanu'ávaha) that is currently being implemented in the schools located within the Karuk Aboriginal Territory and homelands, and align with the California Common Core State Standards for English-Language Arts and/or the Next Generation Science Standards (NGSS) for California Public Schools.

Upon contract award, the Contractor will read, sign, and adhere to the principles set forth in the *Protocol with Agreement for Intellectual Property Rights of the Karuk Tribe: Research, Publication and Recordings.* Please note the following: Under these binding legal documents, all copyrights to lessons developed under this contract shall be owned by the Karuk Tribe. ## Scope of Work

## Task One: Draft Curriculum Materials for Native Health Lessons

Contractor will develop four new age-appropriate lesson plans (between the 5<sup>th</sup> through 9<sup>th</sup> grade levels) to guide both in-class and field studies. Each 1.5-hour lesson (two 45 minute sessions) will balance the teachings of Western- with Native science, targeting middle and high-school grade levels with content focusing on tribal physical health in connection with the local traditional food system.

## Lesson materials will align with the Karuk Tribe's Nanu'ávaha K-12 Native Food System

**Curriculum** and align with the California Common Core State Standards for English-Language Arts and/or the Next Generation Science Standards (NGSS) for California Public Schools. All four draft lesson plans will be submitted in electronic form to the Píkyav Field Institute Program Manager (Program Manager) for review by Aug. 25, 2018.

## **Task Two: Finalize Native Health Lessons**

Upon receiving reviewed materials by Sept. 1, 2018, Contractor will integrate all suggested revisions, edits and additions, and submit final lessons to the Program Manager by Sept. 15, 2018.
