The Karuk Tribe is seeking proposals from qualified firms and individuals to develop a proposal for a *Judicial Office remodel project* under the Indian Community Development Block Grant (ICDBG) funding opportunity.

The Karuk Tribe has purchased a building to be remodeled and retrofitted to meet the needs of the Tribal Court. The successful candidate will work closely with the Court Administrator, Tribal Council, staff and participating committees with planning and proposal development. The respondent should be able to assist the team in developing a proposal that demonstrates the need for court services and other related services within the specific ICDBG guidelines of serving low to moderate income individuals.

In general the respondent should have demonstrated experience in grant writing including strong writing, editing and proofreading skills, and documented success of receiving grants from multiple funders, specifically ICDBG.

Proposals must include:

- 1. A cover letter/statement of qualifications identifying relevant experience and the results/benefits achieved. (Maximum two (2) pages).
