The Karuk Tribe requests proposals for the following Scope of Work required for the demolition and removal of existing sewer line from the Klamath River RV Park located at 110 Nugget St. in Happy Camp, Ca. The existing clay line, that links the junction at Nugget St. and the main line at Hwy 96, has settled over time and is currently sagging and causing flow issues to the main line. This line will be abandoned in place and a new 6" PVC line installed at proper angle to promote adequate flow as well as appropriate and required accesses to the line (manholes/cleanouts). All State and Local code must be strictly followed. All applicable permitting and inspections will be the responsibility of the Contractor.

Task One – One Call locates and Identifying Underground Hazards

It is the responsibility of the awarded Contractor to perform the One-Call locates and have all underground utilities properly marked before the start of the project.

Task Two – Trenching

The trenching will be from the junction at Nugget St. to the existing man hole near Hwy 96 (APPROX 180ft). The trench bottom will be at the proper slope or packed bedding material will be used to achieve the angle. OSHA Shoring or Benching regulations will be regarded for any part of the trench that will be occupied for any length of time for any reason.

Task Three – Installation of 6" PVC Sewer line and applicable Manhole access

Each PVC joint will be properly welded according to State and Local regulation and laid into place. Any manhole access that is deemed necessary for efficient and effective future maintenance of the line will be installed at this time as well per State and Local regulations. The contractor is responsible for ensuring the line is set to the proper angle and that adequate bedding is installed around the line to prevent damage while backfilling or compacting.

Task Four – Backfilling and Compacting

After the line has been properly bedded, the new line will be backfilled and compacted in lifts to assure minimal settling. The trench will be left slightly mounded to account for any settling that compacting cannot. The area will be returned to "before construction" condition or better before the project will be finalized.

Responses to this Request for Proposals should include the following:

- 1) A statement of qualifications, including relevant project history.
- 2) A proposed approach and rational for completion of the contract tasks described above, including descriptions of similar work previously completed and the results/benefits achieved.
- 3) A lump sum price, with attached price break-down page.
- 4) Names and telephone numbers of three client references.
