The Karuk Tribe requests proposals for the following Scope of Work required for provision of elementary and high school aged culturally focused treatment groups for tribal youth in Yreka.

Task One - Group Design and Curriculum Development

Coordination with Human Services clinical and administrative staff regarding selection of group design and curriculum selection or development.

Task Two - Provision of 12 week, gender specific groups for elementary and high school aged youth.

Contractor is responsible for scheduling, preparation and facilitation of gender specific culturally focused groups for tribal youth. Location of group will be in Yreka.

Task Three – Develop and complete an evaluation of the program.

Contractor will coordinate with Human services clinical staff to identify evaluation focus, criteria for evaluation and data collection.

Responses to this Request for Proposals should include the following:

- 1) Contractor will provide documentation of demonstrated experience in coordinating and facilitation of groups with youth.
- 2) A proposed approach and curriculum selection.
- 3) A description of proposed cultural activities to be included in group.
- 4) Submit to a Department of Justice background check.
- 5) A lump sum price, with attached price page.
- 6) Names and telephone numbers of three client references.
