The Karuk Tribe requests proposals from qualified firms for the following scope of work; develop a set of schematic drawings and cost estimates for the renovation and expansion of the multipurpose room "old gym" located at 64236 Second Avenue in Happy Camp, CA. The drawing should be for the renovation and redesign of the space including additional square footage for offices and a rest room. This building is believed to have been built in the 1940's -1950's and has tested positive for mold and lead based paint. The cost estimates should reflect the recommended type of construction and implementation schedule.

Due to the age and condition of the facility the selected firm will be required to visit the site during the planning and redesign phase of the project to ensure that all drawings and estimates are accurate and feasible. It is understood that these planning documents shall be delivered to the Karuk Tribe no later than 30 days from the date of selection.

Firms must be include a statement of qualifications or resume with their submission. It is understood that this document may be submitted to funding sources in the future as a means to obtain funding for the renovation of this facility. Once a firm is selected a site visit will be scheduled to ocurr within 10 days.

#### SCOPE OF WORK

#### 1. Schematic Drawing:

Firm shall coordinate with project team to redesign the existing space to maximize utilization as well as expand the building foot print to include additional offices. Final project will include:

- Large community gathering room/meeting area
- Restroom
- Men/women's showers/rest rooms (existing showers are original and will need complete rebuild)
- Commercial Kitchen (existing kitchen is original and will need complete rebuild)
- Food Storage and Ice Machine
- Table/chair & Emergency supply storage area
- 3 Offices and possible conference room

- Cost estimate and cost per square foot
- List of renovations and per remediation's
- Implementation Schedule

#### Additional conditions to be considered:

- Upgrade or replacement to electrical
- Upgrade or replacement of all lighting
