Representatives from the Yreka area & surrounding community are desired, however, any Tribal Members from the Somes Bar, Salmon River, Orleans and Happy Camp who are interested should submit an Application for Consideration in case no Yreka residents are interested.

The ICWA Committee was created for the purpose of *protecting the best interests of the child and promoting the stability and security of the Karuk Tribe and its Indian families by fully exercising the Tribe's rights to responsibilities under the Indian Child Welfare Act of 1978 and the Karuk Tribe's ICWA policies.*

The Committee meets at least once each month in Happy Camp, Members are expected to travel as necessary to attend meeting, training, and conferences. Members are compensated with \$50 stipends for their time at meetings. Mileage is paid if the meeting location requires travel.
