The Karuk Community Development Corporation (KCDC) is currently accepting applications from interested Tribal or other community members to serve on the Karuk Community Development Corporation Board of Directors. There is one (1) vacancy on the Board and we are accepting letters of intent from all communities for consideration.

The mission of the Karuk Community Development Corporation is "to develop among Tribal members of the Karuk Tribe the managerial and technical capabilities to assume leadership roles in building diversified, sustainable economies by creating new business ownership and employment opportunities within the ancestral territory of the Karuk people."

The Board of Directors meets twice each month at 5:30 PM in Happy Camp. Board Members are expected to travel as necessary to attend meetings, trainings, and conferences. Board Members are compensated with \$75 stipends as compensation for their time spent at meetings. Mileage is paid to Board Members who must travel to Happy Camp from another community at the currently approved federal POV rate.
