Happy Camp Area

The Karuk Tribe Housing Authority is seeking two qualified high school **STUDENT MENTORS** for the <u>Healing of the Canoe Program</u>, catering to Native Youth in grades 4th-8th and 9th-12th. Responsibilities include assisting the group facilitator and cultural practitioner during sessions. Your role is vital in creating a positive and supportive environment for youth participants, leading and guiding them while maintaining a clear leadership presence. Applicants must maintain good standing in school and lead a clean, sober lifestyle. Sessions are scheduled twice a week (Mon-Thurs) from 3:00 pm to 5:00 pm, spanning 9 weeks. Compensation is \$1,120 for 14 sessions, with 2 hours per session. There are two available positions, one for each age group, for the Happy Camp area. Individuals may apply for one or both positions, if interested.

Program Description: Healing of the Canoe is a program for Native Youth, addressing suicide and substance abuse prevention. It is customizable for each community, integrating traditions to strengthen youths' connection to culture and boost hope. Using the Pacific Northwest Canoe Journey metaphor, the curriculum imparts life skills to navigate challenges without succumbing to alcohol or drugs. Lessons are enriched with the essence of Karuk dances, creating impactful teaching moments.

Task One

Assist group facilitator and cultural practitioner during groups. As a Youth Mentor for the youth group, your responsible for the following:

- a) Help organize and execute planned activities for the youth.
- b) Complete sign-in sheets and surveys as required for program documentation.
- c) Distribute snacks to participants, including set up and clean up.
- d) Assist in the set up and clean-up of both lesson plans and cultural activities.
- e) Thoroughly familiarize yourself with the materials and activities planned for each session.
- f) Actively engage and interact with the children to provide support and mentorship.
- g) Step into a leadership role, making sure to guide and support the youth while clearly showing that you are their leader.
