The Karuk Tribe is seeking proposals from qualified contractors for the renovation of the Karuk Tribe Head Start Playground in Happy Camp, CA. The goal of this project is to enhance the outdoor play area with new landscaping, shade structures, and safety features to provide a safe and enjoyable environment for children.

I. SCOPE OF WORK

The selected contractor will be responsible for the following:

- 1. **Tree Planting** Supply and plant trees suitable for the local climate to provide natural shade and aesthetic enhancement. (2-3 trees)
- 2. **Sod Installation** Provide and install high-quality sod to create a lush, green play area. (35'x 15' and 25'x25')
- 3. **Shade Structure** Purchase and install durable shade structure that complies with safety regulations and is appropriate for a playground setting. 2 (20'x20') and 1 (15'x15').
- 4. **Sandbox Installation** Purchase and install child-friendly sandbox materials to expand current sandbox with appropriate safety measures.
- 5. Wood Chips Supply and spread wood chips in designated areas to ensure a soft and safe play surface.
- 6. **Cement install** Clearing, preparing, ensuring proper drainage, and reinforcement materials, selecting and providing cement mix specifically designed for outdoor use to install properly poured and sealed cement floor for outdoor classroom space. (35'x15)

II. PROPOSAL REQUIREMENTS

Interested contractors must submit a proposal that includes the following:

- 5. **Proof of Licensure and Insurance** Valid contractor's license and liability insurance coverage.

IV. EVALUATION CRITERIA

Proposals will be evaluated based on the following criteria:

- Experience with similar projects (30%)
- Project approach and timeline (25%)
- Cost-effectiveness and budget feasibility (25%)
- References and past performance (20%)
