Summary:

Under general supervision of the Director of Hospitality, responsible for the daily supervision of Food and Beverage outlets in casino. Ensures that all food and beverage operations are executed to achieve established quality, service, safety and financial goals and objectives and in accordance with all applicable established laws and regulations.

Responsibilities:

- 1. Manage dining room floor.
- 2. Line Check taste all food products checking for quality and that the products meet RRC established standards.
- 3. Complete paperwork, daily reports, menu analysis, cost analysis and ordering products from computer.
- 4. Manage staff including scheduling, employee counseling, PTO, etc.
- 5. Training all employees.
- 6. Act in accordance with Handbook personnel procedures, operating procedures, minimum internal control standards, and regulations.
- 7. Assist all team members as needed.
- 8. Update policies and procedures as needed.
- 9. Maintain confidentiality over all personnel information.
- 10. Maintain an efficient filing system and document all assets and reconciliations.
- 11. Attend mandatory and non-mandatory training, meetings, and briefings



- 12. Maintain appearance standards as outlined in departmental and Rain Rock Casino policies.
- 13. Provide information and explain Players Club benefits, property amenities & marketing programs to our guests.
- 14. Provide courteous service to our guests and be cordial to all Team Members.
- 15. Communicate effectively both orally and in writing.
- 16. Shall be polite and maintain a priority system in accepting other position related job duties as assigned.

- 7. Highly self-motivated and directed.
- 8. Keen attention to detail.
- 9. Proven analytical, evaluative, and problem-solving abilities.
- 10. Ability to effectively prioritize and execute tasks in a high-pressure environment.
- 11. Extensive experience working in a team-oriented, collaborative environment.
- 12. Must possess and maintain a valid state driver's license and be insurable by the RRC's insurance carrier.
- 13. Must possess and maintain a current food handler's card.
- 14. Must possess and maintain a current RBS certification from ABC.
- 15. Willing to travel and participate in training as recommended or required.
- 16. Must have a Tribal Gaming License (or the ability to obtain and maintain a license) as a requirement for this position.
- 17. Must adhere to confidentiality policy.
- 18. Must successfully pass a drug screening test and criminal background check.
- 19. Indian preference will be observed in the hiring process.
