The Karuk Tribe requests proposals for the following Scope of Work (SOW) required at 110 Nugget St. in Happy Camp, Ca. 96039. The SOW will include the removal and disposal of the entire existing fence currently installed at this property. All of the demo materials will be properly disposed of by the Contractor. The demo fencing will be replaced with the installation of new 6ft galvanized chain-link fence, posts and hardware. The chain link fencing will include vinyl privacy slats along its entirety, including gates, and slat color will be approved by the Owner prior to installation. The fencing will include one vehicle entrance gate approx. 12ft wide, installed as a double swing or single in-line roller design, as well as two - 6ft and one - 8ft pedestrian access gates. Gate supports will be installed with concrete below grade. All gates will be installed in a way and include such hardware as to be lockable by padlock. There is approximately 500 feet of total fencing that will be removed and replaced, not including the four gate access points.
