The Karuk Tribe requests proposals for the following Scope of Work required for the design, engineered plans, and construction of covered ambulance parking in Orleans Ca. Parking structure will be used for access and egress providing adequate protection from wind and weather. Structure to be approximately 75' long and 40' wide. Height to be determined in planning stage. Structure to be free standing and not attached to current facility.

- Permitted and Built according to County, State, Building Code
- Engineered structure to span width and length appropriately
- Meet or exceed snow load requirements with Humboldt county
- Construction not to interfere with daily operation of Tribal Clinic
- Adequate lighting to be developed in planning
- Current underground utility's not to be interrupted
- Minimal changes to current land scape and asphalt
- Color scheme and materials used to match current facility
- All work to be performed by licensed professional in their trade
- All work to be completed in reasonable amount of time per contract
- Contractor to assume all liability (must be bonded)
