The Karuk Tribe requests proposals for the following Scope of Work for a Wellness Court Program Coordinator/ Planner.

Consultant will develop strategic plan and coordinate the Karuk Wellness Court Program to ensure that program participants remain engaged in the treatment program and that the program continues to meet the needs of the participants. Consultant will assist the Administrator in the development of policies, procedures and participant manuals and forms. The consultant shall work closely with Karuk agencies, programs, County and State service providers as well as state and county probation and courts and must maintain confidentiality of all privileged information. Consultant must demonstrate familiarity and experience working with both youth and adults with issues related to substance abuse disorders and drug court models.

Consultants shall meet regularly (up to 10 hours per week) with the Judicial Administrator at the Administrative offices in Yreka, California.

Specific Scope of Services

- 1. Assist the Judicial Administrator in meeting grant requirements inclusive of strategic plan for the wellness court.
- 2. Assist in implementation of the Karuk Wellness Court including development of application process and program requirements.
- Develop in-take process and scheduling procedures for assessments and evaluations of 3. participants.
- 4. Develop referral and release of information forms for program and appropriate treatment providers for a Drug and Alcohol Assessment.
- Assist in development/ implementation of appropriate culturally specific rehabilitation 5. programs tailored to the needs of tribal participant.
- Complete required progress reports, data, collection surveys, and other reports as 6. needed.
- 7. Locate new or existing programs for Wellness Court participants.
- Attend monthly hearings for Wellness Court participants. 8.
- 9. Develop wellness court training plan for team members.
- Attend relevant trainings and meetings as necessary. 10.

- (1) A statement of qualifications, including number of years working for or performing consultant services for a Tribal government and or County government with a description of services provided.

- (3) A proposed approach and rationale for completion of the Scope of Work, including descriptions of <u>similar work completed</u> and the results/ benefits achieved.
- (4) Itemized bid price for hourly rate of pay and expenses; including mileage, travel, and other project related expenses.
- (5) Three letters of recommendation attesting to character and ability to perform tasks listed in this RFP.
