The Karuk Tribe (KT) requests proposals for the following Scope of Work (SOW) required at 110 Nugget St. in Happy Camp, Ca. 96039. The SOW will include the removal and disposal of the entire existing fence currently installed at this property. All of the demo materials will be properly disposed of by the Contractor. The demo fencing will be replaced with the installation of new 6ft solid panel vinyl fencing. This fence is for KT's new child-care facility so, privacy/security is of the utmost importance throughout its entirety, including the gates. The fencing will include one vehicle entrance gate approx. 12ft wide, installed as a double swing, as well as, two – 6ft and one – 8ft pedestrian access gates. Gate support posts, and any other post or hardware necessary, will be installed with concrete below grade to ensure strength and stability. All gates will be installed in a way and include such hardware as to lock automatically from inside the yard, when closed. This is to prevent unauthorized access to the yard from outside and also stop children from being able to operate the locking device and leave the yard. There is approximately 500 feet of total fencing that will be removed and replaced, not including the four gate access points. (See attached map for additional details on fencing route and gate placement).

- Removal and disposal of existing wire fencing
- Removal of vehicle access gate
- Removal and disposal of two pedestrian access gates
- Installation of 6ft solid panel vinyl fence (color TBD by Owner)
- Installation of 12ft vehicle access gate
- Installation of two - 6ft and one – 8ft pedestrian access gates
- Installation and testing of security hardware to ensure proper function
