The Karuk Community Development Corporation (KCDC) is currently accepting applications from interested Community Members to serve on the Karuk Community Development Corporation's Board of Directors. There is currently one (1) vacancy on the Board. The Board would prefer to fill this vacancy with an individual residing in the Somes Bar/Orleans or Yreka areas but are accepting letters from all communities for consideration.

The mission of the Karuk Community Development Corporation is *“to develop among Tribal members of the Karuk Tribe the managerial and technical capabilities to assume leadership roles in building diversified, sustainable economies by creating new business ownership and employment opportunities within the ancestral territory of the Karuk people.”*

The Board of Directors meets twice each month at 5:30 PM in Happy Camp. Board Members are expected to travel as necessary to attend meetings, trainings, and conferences. Board Members are compensated with \$50 stipends as compensation for their time spent at meetings. Mileage is paid to Board Members who must travel to Happy Camp from another community at the currently approved federal POV rate.
