The Karuk Tribe requests proposals for a consultant to work closely with the Karuk Tribe's Department of Natural Resources (DNR) staff in setting priorities for tribal input and participation in the Upslope Collaborative Partnership.

Task One

The consultant will facilitate the development of a Mid-Klamath Upslope Restoration Prioritization Strategy that identifies restoration actions in the Mid-Klamath to complement the Mid-Klamath Subbasin Fisheries Resource Recovery Plan and other existing documents.
