The Karuk Tribe requests proposals for the following Scope of Work required for design and fabrication of one museum quality display case and mounts.

Task One

Sketch drawing for "Library T" custom built museum display case:

- 32" deep x 62" wide x 30" high pedestal with 18" high plexiglass vitrine.
- Linen fabric covered display decks and water based lacquer finishes.
- Opened from the front with no middle seam.
- Medite II panel products with no formaldehyde; no VOC low odor latex paint; display area isolated from base with waterborne polyurethane barrier coat; gaskets of dense or sponge silicone interface between base and vitrine.
- Elevated decks of Medite II.
- Space in elevated deck for selected sorbents.

Task Two

Sketch with dimensions for four (4) various sized linen covered display mounts to match case deck.

Task Three

Pricing for case, display mounts, and shipping.

Responses to this Request for Proposals should include the following:

- 1) A statement of qualifications, including relevant project history.
- 2) A proposed approach and rationale for completion of the contract tasks described above, including descriptions of similar work previously completed and the results/benefits achieved.
- 3) A lump sum price, with attached travel expense rate sheet
- 4) Names and telephone numbers of three client references.
