The Karuk Tribe requests proposals for the following Scope of Work required for the repainting of approximately 1,500 sq. ft. in the Karuk TANF Office located at 1517 S. Oregon Street, Yreka, California. A pre-bid conference has been scheduled for Wednesday, June 27, 2012 at 11:00 a.m.

Task One

Prepare for repainting of interior surfaces, including ceiling. This includes taping, painting, and all clean up. Complete the repainting of the interior surfaces, including ceiling. Paint color will be selected by the Tribe. Ceilings shall be flat finish and office walls shall be satin finish. Restrooms, hallways, break room, and all trim shall be semi-gloss finish. All materials necessary for preparation, repainting and clean-up must be provided by the bidder.

Task Two

All proposals must be a flat rate for the entire job; proposals with hourly rates WILL be considered non-responsive. Time necessary to complete the project will be considered together with price when selection takes place. Time necessary to complete the project will be considered together with price when selection takes place as deadline for completion is no later than July 13, 2012.

Responses to this Request for Proposals should include the following:

- 1) A statement of qualifications, including relevant project history.
- 2) Contractors must provide their current contractor's license number and bonding documentation.
- 3) A proposed approach and rationale for completion of the contract tasks described above, including descriptions of similar work previously completed and the results/benefits achieved.
- 4) A lump sum price, with breakdown of labor, materials, etc.
- 5) Names and telephone numbers of three client references.
