The Karuk Tribe requests proposals for the following Scope of Work required for a Museum Registrar Consultant. This is a project funded by an IMLS NANH Museum Services grant ending September 30, 2013.

Task One

Set up written procedures for accessioning permanent collection and loans, implementation and maintenance of all records. These instructions will be collected into a collections management workbook for current and future staff.

Task Two

Accession the permanent collection into PastPerfect museum software. Research donor and lender information and any access/use restrictions. The collection contains approximately 300 items, including baskets, lithic materials, and ceremonial regalia. Fabricate archival storage for objects not on display using best museum practices for collections management, including labeling and storage of objects.

Task Three

Recommend supplies, materials, and systems for collections management and provide up to 5 days training for staff.
