Proposals shall include all time and tasks necessary for shopping, food preparation, service, and related services for the meals and menus attached. (the menu items are not specific and can be modified).

Service also includes providing all paper goods, utensils, condiments, and trash bags, removal of trash and spill clean-up in the serving and eating areas, assistance with setting-up of tables/chairs for serving and overall clean-up of the facilities.

<u>Service should be planned for up to 35 guests daily.</u> Respondents MUST possess current Food <u>Handler's Certificate.</u>

Task One

Consult with Happy Camp Site Leader for supplies and menu items for shopping list. Obtain items with funds provided and turn in receipts for all purchases.

<u>Task Two</u>

Prepare or cook menu items daily. Sanitize and clean up preparation areas and eating areas according to Grange Hall requirements.
