The Karuk Tribe Housing Authority requests Statement of Qualifications for various areas of Cultural Practitioners to provide their knowledge and/or coordinate activities for upcoming activities. Areas of interest (but not limited to) are:

- Other cultural and historical knowledge, including traditional land management practices.

- Session/s can be scheduled for daytime, evening, and/or weekends. The time will be agreed upon between the presenter and the Resource Development Manager.
- Presenters will be paid \$50 stipend for less than 4 hours, \$100 Stipend for 4-8 hours, and multiple days up to \$300 stipend for controlled group session (small groups using COVID guidelines and meeting outside) and Zoom presentation (We can discuss how this works for each individual).
- Duration of presentation will depend on activity.
- Presentation should provide cultural knowledge.
- Class supplies list will need to be provided to Development Manager for approval.
- Must have good internet access with Zoom capabilities for presentation.
