The Karuk Tribe is seeking **five (5)** knowledgeable **GUEST SPEAKERS** for the <u>Healing of the Canoe Program</u>, specifically for Native youth in grades 4th-8th grade at Jackson Street School. Presentation will focus on suicide and substance abuse prevention or dance protocol or knowledge that will help our youth live a healthy life style. This curriculum provides essential skills for navigating life's journey without being swayed off course by alcohol or drugs. We see Karuk culture as the compass and anchor guiding this journey. If you are available and interested in being a guest speaker, please let us know your availability and any specific topics you would like to address. Dates will be scheduled when guest speakers are selected. The compensation is \$50 for one session, with 2 hours interaction with youth. Our goal is to have local people to avoid travel cost. We can offer limited out of area speakers if needed. There is **five (5)** available position for interested individuals. Payment will be received once an invoice is submitted after presentation is completed.

Program Description: Healing of the Canoe is a program for Native Youth, addressing suicide and substance abuse prevention. Its customizable for each community, integrating traditions to strengthen youths' connection to culture and boost hope. Using the Pacific Northwest Canoe Journey metaphor, the curriculum imparts life skills to navigate challenges without succumbing to alcohol or drugs. Lessons are enriched with the essence of Karuk dances, creating impactful teaching moments.

Task One

Guest speaker presentations offer an accurate picture of healthy living, focusing on suicide and substance abuse prevention, dance protocol, or knowledge promoting a healthy lifestyle for youth.

- a) Share current research, statistics, and best practices in youth suicide and substance abuse prevention.
- b) Demonstrate expertise in Karuk dance protocol, history, and associated cultural practices. Proficient in understanding and maintaining the dance area, including care of cultural items.
- c) Develop engaging educational materials for the target audience, integrating statistics, facts, and prevention strategies.
- d) Coordinate with the lead facilitator for necessary presentation equipment.
