# **Director Reports:**

# 1) Bill Tripp, DNR Director

Bill had a meeting in DC that went well and had got given a chief's coin to chairman Russell Attebery, Bill will interoffice it to Happy Camp.

Cultural burning has been going well, thinking they have broken a record for burning parcels in one day, they did 6 different parcels. Kenneth asks about a spot near china grade road in Happy Camp being a dangerous spot that may need some burns. Bill responds saying they plan to burn it next year.

Did have someone reach out for the director position but did not get to talk to him very much as he was asking for extra things that council would have to approve. Has not applied yet.

### 2) James Davis, Self-Governance Director

James has made notable progress in three key areas: resolution tracking, improving the consultation process, and consistently drafting and receiving Letters of Support (LOS). Kenneth emphasized the importance of the LOS documents, noting their role in strengthening the Tribe's position. Scott suggested preparing a support letter for upcoming consultations that James has scheduled. James agreed and mentioned he will work with Crystal Jacobs to draft it.

Kristen asked about the list of resolutions James previously sent. James explained that a recurring issue is the delay in receiving signed resolutions, as some individuals are not returning them promptly after obtaining signatures, which constitutes a breach of policy. Arch recommended that when presenting resolutions, staff bring two copies for signature and send an additional copy to James for tracking purposes.

James also noted ongoing issues with DocuSign, stating that while it's helpful for those traveling, it often causes delays when users are not actively checking or completing the process.

Additionally, James informed the Council of a Parcel B meeting scheduled for Monday, which will include attendance from state representatives. Kenneth confirmed he and a few other Council members plan to attend.

#### 3) Tyvin Whittaker, Public Information Director

Tyvin presented two action items, one of which is the drone use policy he drafted for his department. Scott asked for clarification and confirmed that the current policy applies only to Tyvin's department. He suggested the possibility of creating a tribe-wide drone use policy that would allow broader staff access, provided they complete the required training, as Tyvin has. Scott also requested that Tyvin draft a formal notification for the KTHA Director, DNR Director, and the Chairman regarding the policy. Council approval will be required for this as well.

Consensus: for Tyvin to draft drone policy tribe wide and a notification to document for the public and staff.

Tyvin expressed interest in bringing on someone to assist with video editing, noting that the task is very time-consuming. He shared that a photo he took just yesterday has already reached 89,000 views, highlighting the impact and reach of quality media. He emphasized that having dedicated support for video editing would significantly enhance visibility and engagement.

Jack expressed interest in purchasing a building in Yreka for use by the DNR. The building currently has two tenants occupying the upper floor, while the bottom floor remains vacant and open for use. Scott indicated a preference for the building to be fully vacated. One of the current tenants provides psychological services to law enforcement, while the other resides in the building and occasionally offsets rent by performing handyman work.

Additionally, there is a person who is currently in a tribal trailer and is not tribal but wants to know if he can buy the trailer out from the Karuk Tribe.

<u>Informational:</u> Erin would like to change a requirement on the PIC position being the 1-year experience changed to a demonstrated knowledge and implement a skills test. Eli wonders if we could streamline the procurement.

<u>Informational:</u> To go with the procurement clerk there should be a standardized vehicle makes and models to show consistency across the board.

Informational: Evaluations were done and Erin considered raises for who didn't get one last year. One employee got their probation status removed.

Informational: The health department got behind on there expenses an it needs to be spent by Monday, the health department thought that bonuses for employees would be a good way to spend it down.

<u>Informational:</u> Council member King asked about the reconstruction of the Orleans council chamber coming out of ARPA, the bidder still has to the middle of July to get fully bonded.

<u>Informational</u>: The job description for the economic development coordinator needs to be changed on who they report to, clarify that they report to council.

Consensus: To change the contract compliance job description as who they report to.
